Treasurer's Report

LENAPE TRACKING CLUB OF CENTRAL NEW JERSEY

Treasurer's Report as of 11/04/2024

This report covers the period from January 1, 2024 to November 4, 2024. Over that period the decrease in the checking account balance was \$1,228.04. The balance in the club account is \$16,142.71.

On October 6, 2024, the Club held its Tracking Dog test. There were 8 dogs entered in this test. Entry Fees totaled \$750 and expenses were \$878.49 for a net loss of \$128.49.

On November 3, 2024 the Club held its Tracking Dog Excellent test. There were 4 dogs entered in this test. Entry Fees totaled \$600 and expenses were \$459.08 for a net gain of \$140.92.

All obligations are paid in full and accounts reconciled.

He’s the breed’s 13th Dual Champion, a derived prefix title awarded to dogs with championships in both conformation and their breed’s heritage sport, the 5th Grand Champion Dual Champion Malinois, the 4th Herding Champion Malinois with an Obedience Utility title, and the 1st Herding Champion Malinois titled in Tracking. 

Lenape Events: TD at Finn Park

The Lenape Tracking Club of Central NJ held its 34th TD test on 10/6 at Finn Park in Pittstown, NJ. Our judges were Gina DeAlmeida and Sue Snyder. We offered 10 tracks, but 3 dogs pulled, so only 7 tracks were run. It was a picture-perfect day and the fields were in great shape thanks to some of the recent rain that we've had. Almost no cloud cover with occasional light breeze and temperatures ranged from low 60s to low 70s. We had 3 dogs pass. On Track 2 was a Porcelaine, (an AKS FSS sight hound) Aria's Bijou De Lune, owned by Kiko Nobusawa & David Pacun. She did a great job and although she struggled a bit on the last turn, good handling kept her searching, and she soon found her glove.



The second dog to pass was a black Lab, Deep Run Mishka CGC, owned by Galina Skerker. This dog had a rock-solid run on her track and easily found her glove.



The third dog to pass was a yellow Lab, Cresthill's Irish Sunshine RN BCAT SCN BCAT SCN SIN SEN owned by Linda and Ken Solakian. This dog also did a great job on his track. His final turn was in a hollow, but the dog worked non-stop until he found the correct direction to find his glove.





It was a great test, with exceptional track layers and volunteers. And as always, the post-test lunch was fabulous.

Our TDX test is scheduled for Nov. 3 also at Finn Park. We will be offering 6 TDX tracks. Hope to see some familiar as well as new faces.
